3 October 2013, JAKARTA – PT Indika Energy Tbk. ("Indika Energy") announces that during the Business Forum Indonesia – China held today it has signed a principal agreement with China Railway Group Limited ("CREC") to jointly develop mining and transportation infrastructure projects in the Papua and Central Kalimantan provinces in Indonesia.

It is estimated that the value of the engineering, procurement, construction, operation and maintenance contracts related to these projects is approximately 6 billion US dollars.

CREC is a large conglomerate and a listed company based in Beijing, People's Republic of China, with a range of expertise in infrastructure, transportation, property, investment, manufacturing and business management in numerous other disciplines.
